- Attended annual GRA conference in Savannah, GA. Many members volunteered on various committees and participated in facilitating training sessions. A commemorative plaque of appreciation was taken to be presented to former chapter president, Sharon Brown.
- Held 50/50 raffle for donations for our chapter where 2 tickets were sold for \$1. Total ticket donations came to \$288. Half of that amount was awarded to the winner (Shirley Turner) which left a total of \$144 to be added to our chapter budget.
